## SECTION VII · HEALTH AND FIRST AID

**PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:**

**Eyes:** May cause irritation accompanied by stinging, tearing, redness, and swelling.

**Skin:** Frequent or prolonged contact may cause irritation and possibly dermatitis. May aggravate existing skin conditions.Á

**Inhalation:** Inhalation of mist can cause irritation of nasal and respiratory passages.
